Selected Litigation & Advocacy

<u>Smith v. Ryan</u>, No. 16-8071 (2017). Lead Counsel on *amicus curiae* brief filed before the United States Supreme Court in support of a petition for Writ of Certiorari urging the Court to consider international and regional law on the issue of the death penalty. The Court did not grant certiorari in the case.

<u>Fisher v. University of Texas II</u>, 579 U.S. (2016). Lead Counsel on *amicus curiae* brief filed before the United States Supreme Court on behalf of five organizations urging the Court to consider the U.S. treaty obligations and practice of other countries in assessing whether the University of Texas' holistic admission policy which includes race as one of seven factors meets the strict scrutiny standard under the U.S. Constitution. The Supreme Court upheld the University of Texas' admissions policy.

<u>People v. Franklin</u>, Lead counsel on *amicus curiae* brief filed before the California Supreme Court challenging 50 year sentence for offender who was 16 years old at the time of the crime. (Filed June 5, 2015.) Court ruled that legislation allowing for juvenile offenders to apply for parole after 25 years was retroactive to this case and remanded the case for a preliminary hearing related to the age of Mr. Franklin. (2016)

<u>Connecticut v. Santiago</u>, 49 A.3d 566 (2015). The Connecticut Supreme Court ruled that abolishing the death penalty has to be applied retroactively to the people already on death row. I was lead counsel (*pro hac vice*) on an *amicus* brief filed on behalf of eleven organizations and law professors from Connecticut and Europe addressed the international standards of retroactivity of ameliorative legislation especially in dealing with the death penalty. (Filed February 2013.). The second concurring opinion refers to the amicus brief and includes a full paragraph on international practice citing to one of the reports we referred to.

<u>People v. Moffett (S206771) and People v. Gutierrez (S206771)</u>, 324 P.3d 245 (Cal 2014). Lead counsel for *amici curiae* raising international and treaty law in urging the California Supreme Court to hold that juvenile without parole sentences are unconstitutional. The brief is filed on behalf of five organizations involved in international law and juvenile justice issues. On May 5, 2014, the California Supreme Court held that sentences of life without parole for juveniles are unconstitutional if the sentencing judge is not able to consider the age of the defendant at the time of sentencing and remanded the cases for resentencing.

<u>Hill v. USA</u>, Lead counsel on *amicus brief* filed before the Inter-American Commission on Human Rights (IACHR) in support of a petition filed by a number of juvenile offenders serving life without parole sentences in Michigan. The brief covers international and treaty standards that prohibit the sentence and was filed on behalf of human rights organizations, university centers, and a professor. The IACHR held a hearing on the case in March 2014. (Filed February 2014.)

<u>N.I. Sequoyah</u>, Petition No. P-120-07, Case No. 12.754, Petition filed before the Inter-American Commission on Human Rights (IACHR) alleging violations of the American Declaration of the Rights and Duties of Man on behalf of an inmate on death row in California. The IACHR decided that the case was admissible on March 17, 2010 and the case is now awaiting a decision on the merits.

People v. Davis (Ill. S. Ct. Case No. 115595), Lead counsel (pro hac vice) for amici curiae urging the

Illinois Supreme Court to hold juvenile life sentences unconstitutional. The brief is filed on behalf of eight organizations and addresses the international and treaty standards relevant to this issue. (Filed August 2013).

<u>Fisher v. University of Texas</u>, 575 U.S. (2013) Lead counsel on *amicus* brief in a case before the United States Supreme Court on whether the University of Texas' holistic admissions policy which includes race is unconstitutional. The brief was filed on behalf of five *amici* and urged the Court to consider United States' treaty obligations in upholding the University's practice.

<u>Miller v. Alabama, Jackson v. Arkansas</u>, 567 U.S. (2012). Lead counsel on *amicus* brief in a case before the United States Supreme Court involving juvenile life without parole for two 14 year olds. The brief is filed on behalf of 27 *amici* and urges the Court to consider international law and practice in determining whether the sentences are constitutional.

<u>People v. Caballero</u>, Co-counsel on *amicus* brief raising federal and international and treaty law urging the California Supreme Court to hold that a 110 year sentence by a juvenile for a non-homicide crime unconstitutional. The Court did hold that the sentence was effectively a juvenile life without parole sentence for a non-homicide crime and was thus unconstitutional under the *Graham* case.

<u>Graham v. Florida</u>, 560 U.S. , 130 S. Ct. 2011 (2010). Lead counsel on *amicus* brief using international and English law urging the Court to hold the use of juvenile life without parole sentences unconstitutional. The brief and law review article were cited by the majority opinion.

<u>Roper v. Simmons</u>, 543 U.S. 551 (2005). Lead counsel on *amicus* brief using international and English law to support the finding of the Missouri Supreme Court that the execution of juvenile offenders violates the Eighth Amendment. Brief was cited twice in the majority opinion.

<u>Grutter v. Bollinger</u>; <u>Gratz v. Bollinger</u>, 539 U.S. 306 (2003). Authored *amicus* brief arguing that two treaties that the United States is party to support the University of Michigan's special admissions programs.

<u>Beazley v. Johnson</u>, 2001 U.S. LEXIS 5264. Authored *amicus* brief arguing that the juvenile death penalty had risen to the level of a *jus cogens* norm and that Article 6 (5) of the International Covenant of Civil and Political Rights is self- executing.

<u>Sanders v.Woodford</u>, CV-F-92-5471-Rec-D. Authored *amicus* brief arguing that seventeen years on death row is cruel, inhuman, and degrading treatment in violation of the International Covenant on Civil and Political Rights.

<u>Williams v. United States</u>, Petition to the Inter-American Commission on Human Rights alleging violations of the right to life provisions of the American Declaration of the Rights and Duties of Man, filed November 2000.

<u>Bryan v. Moore</u>, cert. dismissed, 528 U.S. 1133 (2000) Authored *amicus* brief urging the Supreme Court to consider treaty standards in defining whether the Florida electric chair violates the Eighth Amendment.

<u>Domingues v. Nevada</u>, cert. denied. 528 U.S. 963 (1999). Authored *amicus* brief urging court to consider treaty provisions and customary international law in determining whether a juvenile death sentence is valid.

<u>Coalition for Economic Equity v. Wilson</u>, cert. denied. 522 U.S. 963 (1997). Authored *amicus* brief urging court to consider treaty provisions in determining whether Proposition 209 is valid.

<u>Washington v. D.B. Coopers</u>, (1994-1997) Santa Clara Municipal Court. Civil Rights action alleging violations of the California Unruh Act. Seven day jury trial resulted in \$25,000 for one of the plaintiffs.

<u>Fierro v. Gomez</u>, 77 F. 3d.301. (9th,Cir. 1996) cert. granted and judgment vacated 519 U.S. 918, 64 U.S. LW.3780 (Oct. 15, 1996). Authored *amicus* brief urging court to consider Human Rights Committee decision regarding the California gas chamber in determining whether the latter violated the Eighth Amendment.

<u>Hilao and Sison v. Estate of Marcos</u>, 103 F. 3d 789, (9th Cir. 1996). Authored *amicus* brief arguing that the prohibition against cruel, inhuman, and degrading treatment has risen to the level of international customary law and that the tort of torture necessarily involve pain and suffering.

<u>Orozco v. County of Yolo</u>. 814 F. Supp. 885 (E.D. Cal 1993). Civil rights case involving fourth and fourteenth amendment claims as well as state causes of action on behalf of five plaintiffs. Case settled for \$450,000 after plaintiffs won several motions.

<u>Butt v. Richmond Unified School District</u>. 4 Cal 4th 668 (1992). Authored *amicus* brief arguing that international law would be useful in appraising prior rulings on the fundamental nature of the right to education and the appropriate level of scrutiny under California equal protections standards.

<u>Curtis v. Oakland Housing Authority</u>. 746 F Supp. 989 (N.D. Cal. 1990). Superior court action removed to federal court; class action challenging public housing authority's failure to provide or repair stoves in its operating units. Court ruled that defendant breached its contract with HUD.

<u>Diaz v. Franchise Tax Board</u>-Nos. 812 322 & 90113-0. San Francisco Superior Court, class action challenge to FTB's practice of denying head of household renter's audit to persons receiving AFDC. Represented individual client before the state Board of Equalization and assisted with implementation of settlement resulting in \$220 million in refunds to taxpayers (1983-1990).

<u>Central Valley v. Younger, Gresher v. Deukmejian</u>, 214 Cal. App. 3d. 145 (1989). Superior Court class actions; assisted in discovery, pre-trail motions and trial. The court granted a judgment prohibiting a wide range of practices followed by the State Bureau of Identification in disseminating and maintaining arrest record information. The court also required the Bureau to add disposition information to arrest records promptly (1984-85).

Image v. Bolger- Federal District Court; class action: assisted with discovery and preparation for

trial in Title VII case against the U.S. Postal Service. Settlement provided for increased hiring of Hispanics for several job classifications in the Bay Area. I was also responsible for the monitoring of the Consent Decree (1982-1989).

Superior Court Alameda County class action; negotiated settlement to institute due process procedures prior to terminating patients from the methadone maintenance program as well as giving the patients access to their medical records. (Filed March 1986).

<u>Nelson v. Oakland Housing Authority</u>-negotiated agreement to institute due process procedures prior to denying applicants admission to the Section 8 Housing Program and prior to terminating participants pursuant to federal requirements. (1985)

<u>Perkins v. Condor Management Company</u>- administrative complaint filed with the Department of Housing and Urban Development; negotiated settlement to institute due process procedures for processing and denying applications at a subsidized housing project. (1985)

<u>Doskocz v. Housing Authority of Alameda County</u>. No. C80-0448 WAI (N.D. Cal.) Superior Court action removed to Federal District Court: class action; negotiated settlement requiring good cause before Section 8 tenants could be evicted. (Filed January 1980.)
